- Use of a motor vehicle in a felony involving the manufacturing, distribution, or dispensing of a controlled substance
- Violations of military, state, or local law relating to motor vehicle traffic control (other than a parking violation) arising in connection with any traffic crash and have no record of a crash in which I was at fault.
