- The Bill of Sale, if included in the purchase. (A Bill of Sale is required for purchases from a Dealer)
- Form of payment: check, cash, Visa, Mastercard, Discover or American Express.
- ADDITIONAL DOCUMENTATION MAY BE REQUIRED
